General Tournament Information

Play is governed by the USGA Rules of Golf and its Decisions and, where applicable, by the following Local Rules, Conditions, and Definitions.

Tournament Registration: All tournament entry fees **MUST** be paid at the time of registration to hold a spot using the online link provided.

Confirmation & Other Communication: All tournament participants will receive a confirmation email upon on-line registration. A second email will be sent to all participants on the day prior to the event to confirm event details.

Cancellations and No Shows: Tournament reservations may be cancelled up to 48 hours prior to the tournament and will receive a full refund. Any cancellations made after 48 hours will not receive a refund but will be given a raincheck for the host course and tee gift if applicable.

Handicaps: We will follow the USGA handicap guidelines for all events. All player handicaps will be verified before play.

Ties: Unless the Notice to Competitors states otherwise, ties in stroke play competition will be broken by the USGA method.

Tournament Changes: Every effort will be made to maintain the posted tournament schedule. However, in the event of unforeseen conflicts and/or inclement weather, Founders Golf International reserves the right to make the necessary adjustments regarding the event.

Additional Local Rules: Each Founders Collection course has specific and unique local rules. Please review the event rules sheets provided at each Prime Times Honors Club event in its entirety.

Eligible Participants: FGI reserves the right to open and restrict tournament registrations at any time.

Eligibility of PGA Professionals: Prime Times Honors Club Events are open for participation by all Prime Times Honors Club members. Members or guests of members with past or current professional status are permitted to participate in all Prime Times Honors Club Events.

Inclement Weather Plan of Action:

Cancellation of events plan:

In the event of unfavorable weather, we will decide whether to play or cancel the tournament that morning after consulting the course superintendent and head professional. In the event of cancellation, we will communicate this as early as possible.

Interruption of play plan:

Signals for the Suspension and Resuming play will differ by golf course. Information on the specific signal to notify players of these situations can be found by speaking to the Head Golf Professional or General Manager at each facility.

When play is suspended for a dangerous situation, if the players in a match or a group are between the play of two holes, they shall not resume play until the professional staff has ordered a resumption of play. If they are in the process of playing a hole, they shall discontinue play immediately and shall not thereafter resume play until the professional staff has ordered a resumption of play." All practice areas shall be closed during suspension for a dangerous situation until the professional staff has declared them open for use. Contestants are informed that they have the right to stop play if they think lightning threatens them, even though the professional staff may not have specifically authorized it by signal.
